Shipping/Delivery Information

- Exhibitor product should be shipped and stacked on pallets and must have your booth number stamped on every box, pallet, crate, and/or package. Failure to follow these instructions may cause loss of product. We also encourage you to use the daily color-coded labels provided by IFPA to ensure that the proper product is delivered to your booth each day.

Directions to the Facility

From The North:

1. Slight right to merge onto I-75 S toward Tampa 55.6 mi
2. Slight left at FL-91 S (signs for Orlando/Florida Turnpike S)
Partial toll road 53.6 mi
3. Take exit 254 for FL-528 toward US-17/US-92/US-441 0.4 mi
4. Keep left at the fork to continue toward FL-500 W/FL-600 E/S Orange Blossom Trail/US-17 N/US-441 N/US-92 E
Partial toll road 0.3 mi
5. Keep left at the fork to continue toward FL-500 W/FL-600 E/S Orange Blossom Trail/US-17 N/US-441 N/US-92 E 190 ft
6. Keep right at the fork, follow signs for US-17 N/US-441 N/US-92 E/Orlando and merge onto FL-500 W/FL-600 E/S Orange Blossom Trail/US-17 N/US-441 N/US-92 E 0.4 mi
7. Turn left at Co Rd 527A/W Landstreet Rd 0.3 mi
8. Continue onto Exchange Dr
Destination will be on the right 0.2 mi - 8801 Exchange Drive

From The South:

1. Take Florida Turnpike North
2. Take exit 254 for US-17/US-92/US-441/Orange Blossom Tr/Florida 528 Toll
Partial toll road 0.5 mi
3. Keep left at the fork to continue toward FL-500 W/FL-600 E/S Orange Blossom Trail/US-17 N/US-441 N/US-92 E 190 ft
4. Keep right at the fork, follow signs for US-17 N/US-441 N/US-92 E/Orlando and merge onto FL-500 W/FL-600 E/S Orange Blossom Trail/US-17 N/US-441 N/US-92 E 0.4 mi
5. Turn left at Co Rd 527A/W Landstreet Rd 0.3 mi
6. Continue onto Exchange Dr
Destination will be on the right 0.2 mi - 8801 Exchange Drive

From The East:

1. Merge onto FL-528 W via the ramp to I-95
Partial toll road 41.6 mi
2. Take exit 4 for Florida's Turnpike toward US-17/US-92/US-441/Orange Blossom Tr
Toll road 0.2 mi
3. Turn left at Co Rd 527A/W Landstreet Rd 0.2 mi
4. Continue onto Exchange Dr
Destination will be on the right 0.2 mi - 8801 Exchange Drive

From The West:

1. Take the ramp to I-275 N 0.2 mi
2. Keep right at the fork, follow signs for I-275 N/I-4 and merge onto I-275 N 0.9 mi
3. Take exit 45B to merge onto I-4 E toward Orlando 71.4 mi
4. Take exit 72 to merge onto FL-528 E toward International Airport/Cape Canaveral 4.2 mi
5. Take exit 4 toward US-17/US-92/US-441/Florida's Turnpike 0.3 mi
6. Merge onto Consulate Dr 0.4 mi
7. Turn left at FL-500 W/FL-600 E/S Orange Blossom Trail/US-17 N/US-441 N/US-92 E 0.5 mi
8. Turn left at Co Rd 527A/W Landstreet Rd 0.3 mi
9. Continue onto Exchange Dr
Destination will be on the right 0.2 mi - 8801 Exchange Drive
